

## DISTRIBUTORSHIP AGREEMENT

### **KNOW ALL MEN BY THESE PRESENTS:**

This agreement is made and entered into by and between----

**GUANGDONG KAIYANG MEDICAL TECHNOLOGY GROUP CO.,LTD.**, a corporation duly organized and existing under the law of the People's Republic of China, with offices at YANFENG INDUSTRIAL AREA, DALI TOWN, NANHAI DIST, FOSHAN, GUANGDONG , CHINA represented by President, MR LIAO YOUFENG, hereinafter called "First Party"

- and -

**COSMETICS AND CHEMICAL MEDICAL EQUIPMENT COMPANY LIMITED**, an establishment duly organized and existing under the laws of Socialist Republic of Vietnam, with address at No 10, Phuong Mai st., Phuong Mai Ward, Dong Da dist., Ha Noi, Vietnam, represented herein by its President, Mrs. Luong Thanh Hang, hereinafter called "Second Party".

### WITNESS: THAT

**WHEREAS**, First Party is a supplier of MEDICAL SUPPLIES originating from mainland China and/or Hong Kong which is desirous to promote, distribute, and sell said products in the Vietnam.

**WHEREAS**, Second Party is willing to meet the desire of the First Party to continue to act as its distributor of MEDICAL SUPPLIES in the Vietnam.

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the Parties hereto hereby agree, one with the other, as follows:

#### **1. Duration**

First Party hereby designates Second Party as its distributor of MEDICAL SUPPLIES products in the Vietnam.

#### **3. Annual Amount**

Second Party shall guarantee the annual minimum purchases of MEDICAL SUPPLIES products from the First Party during the effective period of this agreement as follows:

- (1) First year not less than USD 50,000.00
- (2) Second year not less than USD 100,000.00

- (3) Third year not less than USD 120,000.00
- (4) Forth year not less than USD 130,000.00
- (5) Fifth and over year not less than USD 150,000.00

**5. Force Majeure**

Either party shall not be held responsible for failure or delay to perform all or any part of this agreement due to flood, fire, earthquake, draught, war or any other events which could not be predicted, controlled, avoided or overcome by the relative party. However, the party affected by the event of force Majeure shall inform the other party of its occurrence in writing as soon as possible and thereafter sends a certificate of the event issued by the relevant authorities to the other party within 15 days after its occurrence.


